



RED VAULT PRO TERMS OF USE

These Terms of Use are effective on December 5, 2024.

These Terms of Use ("Terms") govern your access to and use of the services provided by Red Vault Pro ("Red Vault Pro", "we", "us", or "our"), including (a) our website, our application, our software and our other services that reference these Terms (collectively, the "Services"), and (b) any information, text, graphics, photos or other materials uploaded by you, downloaded by you, or otherwise accessed by or appearing on the Services (collectively, the "Content"). Your access to and use of the Services are conditioned on your acceptance of and compliance with these Terms. By accessing or using the Services you agree to be bound by these Terms.

We may revise these Terms from time to time without direct notice to you, and the most current version of these Terms will be available at www.redvaultpro.com/terms. By continuing to access or use the Services after those revisions become effective, you agree to be bound by the revised Terms.

If you are a representative of an organization, we may from time to time, enter into separate enterprise agreements with your organization to govern the use of our Services (the "Enterprise Agreements"). Notwithstanding such Enterprise Agreements, these Terms shall govern and control with respect your use of the Services in your personal capacity.

1. General

You are responsible for your use of the Services, for any Content you post to the Services, any Content you access from the Services, and for any consequences thereof. Account Security: If you are provided with a username, password, credentials file, or any other piece of information as part of any security procedure (collectively, "Credentials"), you must treat such information as confidential and must not disclose it to any other person or entity. You acknowledge that your account and Credentials are personal to you, and you agree not to provide any other person with access to the Services or any portion of it using your Credentials.

2FA Authentication: To enhance account security, we may require you to enable Two-Factor Authentication ("2FA"), which provides an additional layer of protection for your account. 2FA requires a second form of verification, such as a code sent to your mobile device, email, or through an authentication app, in addition to your Credentials.

5. Your License to Use the Services

Red Vault Pro grants you a limited license to access the Services subject to the terms and conditions set forth in these Terms. If you choose to subscribe to any Services, Red Vault Pro grants you a license to access such Services subject to and conditioned upon your payment of the applicable fees and your compliance with all other terms and conditions set forth in these Terms, the Privacy Policy, and any other rules and requirements communicated to you by Red Vault Pro.

6. Intellectual Property Rights; Feedback

Trademarks: Certain trademarks, service marks, and logos, including without exclusion the Red Vault Pro trademark and associated logo (the "Trademarks") used and displayed in connection with the Services are owned by Red Vault Pro.
